Spraying Permit Information

The OLMD is in the process of obtaining a permit for the 2022 season from the Wisconsin Department of Natural Resources to apply herbicides for the control of the aquatic plants in Okauchee Lake. This Notice is required under Chapter NR 107 of the WI Administrative Code.



Goose Round-Up

This year the OLMD will again cooperate with the USDA Fish and Wildlife Service to round up non-migratory Canadian Geese on Okauchee Lake. The Goose Round-Up will take place in mid-June when the birds are flightless.

In order for this project to move forward, we need your consent. We are required to have your consent to access your property before the Round-Up. Once you provide consent, you are no longer required to complete it annually. IF YOU SUBMITTED THE CONSENT FORM TO THE OLMD AFTER 2012, YOU DO NOT NEED TO FILL OUT THE FORM EACH YEAR. IF YOU HAVE NOT COMPLETED THE CON-SENT FORM SINCE 2012, PLEASE RETURN THE COMPLETED GOOSE ROUND-UP CONSENT FORM BELOW BY JUNE 17, 2022.

Welcome Brady Mullikin, OLMD Lake Operations Supervisor!

Brady Mullikin has been working hard for the OLMD since the fall of 2018. This year marks his 2nd year officially running the Weed Harvesting Operations! Brady comes from a fleet and labor management background. "I've done every aspect of this operation from power washing and pitchforking, to hiring and structural fabrication. I plan on giving the residents of Okauchee Lake many years of service and consider this my home lake." Thank you, Brady, for taking time from your busy spring schedule to answer some questions about your new role! What do you want lake residents to know about lake operations for 2022?

We are proud to announce that two of our oldest harvesters are being equipped with new Kubota Diesel engines. These modern engines should cut down on noise while improving reliability. Our outgoing Isuzu C240 engines were over 25 years old and far surpassed their expected lifespans. Additional major overhauls to the fleet were carried out in an effort to further increase reliability and longevity of the heavy equipment. Finally, our facility has been rejuvenated and revamped with an emphasis on efficiency and organization.

What do you wish residents knew about cutting and barging the lake?

The barge crews pick up M-F starting at 8 am! Harvesters will be cutting heavily M-Th. This summer we plan to harvest on Fridays with special attention to the surface to reduce the amount of residual "floaters" that get caught in piers and docks. Weekends are precious on the water and the more we can collect with the machinery, the less time we all spend with rakes and pitchforks.

We expect to haul out around 300 dump truck loads to local farms this summer!

What advice would you like to give residents about weed harvesting or barging?

For Harvesting:

-The Harvesters have no immediate lateral control and cannot safely access every area one might want them to cut.

- -Consider the website schedule as a guide, not the gospel. We will alter cutting plans "day of" if the wind plays a significant factor.
- -Please give the harvesters a wide path to operate in while on the lake. They are essentially zero-turn machines and can pivot faster than one might expect.


For Barging:

-Piles placed at the ends of piers are preferred. -Accessible shoreline piles are great too!

while transferring plant material to the barge. In the event plants must be on the shoreline, they must be in one pile in a location allowing the employees to easily transfer the plants directly to the barge. Please note that adequate space is required between piers, boat-lifts, etc. to safely maneuver the barge to the pick-up point (20 feet minimum). If, in the opinion of the Lake Operations Supervisor (and after discussion with the riparian owner), these conditions are not met, the Commission's policy is to refuse pick up of plant material until the above conditions have been met.

Plants will be picked up Monday through Friday (weather permitting). Please check the OLMD website home page (www.olmd.org) frequently to review the updated cutting schedule. OLMD strongly prefers plant piles directly on piers. In the event that a bin or receptacle is used, please drill drain holes in the bottom. Plants must be free of any trash, such as cans, tree limbs, leaves, etc., because the farmers who receive the plant material will not accept anything except plants. Limitations On Boat Access **By Tom Godar**



Did it seem like a lot of boats to you?

Last year was perhaps the busiest year on Okauchee Lake ever! How were so many boats on the lake, you ask? Boats get on the lake two ways.

Docking on private piers and lifts.

Property owners can moor boats at their lifts and piers; however, there are limitations. According to the DNR website, "The law states that for non-commercial properties or properties with less than three dwelling units, up to two boat slips are allowed for the first 50 feet of shoreline owned and one for each additional full 50 feet of shoreline owned." There are exceptions for piers existing before April 17, 2012, which can keep existing boat slip usage.

Boat Launch Access

A few commercial establishments have certain exceptions for commercial marinas. The number of boats that can be docked at those marinas are as follows: Golden Mast -25 moorings; Hideaway -12

carefully controlled so that once the parking lot is filled no other boats are allowed to launch, even those owned by riparian owners. There is also a conditional permit for The Golden Mast to launch boats throughout the season. Those are regulated to launch no more than 45 boats on a normal day, 60 boats three days per year and 75 boats one day per year. Our records indicate these special days are Memorial Day, the 4th of July, the Tie Up, and Labor Day. This makes Okauchee one of the most accessible lakes in all of Wisconsin, with the resultant high traffic.

We encourage all to use the lake responsibly and safely, which means not exceeding the number of boats allowed for launch or associated or private boat slips. If you believe


> that there has been a violation of these rules or the DNR law, contact the DNR directly and provide as much information as you can to help the DNR determine whether it will follow up on a complaint. You can call 800-TIP-WDNR, or email Kathleen.Kramasz at

additional information you can include, like the property address and photos of the pre-2012 use of the shoreline might be helpful if you choose to have the DNR investigate a possible violation.

Muskrat Control Program Update From Arnold Groehler

The muskrat trapping for this spring started at the beginning of April and will continue into mid-May. The number of muskrats in the lake have continued to decline. There has been a lot



more beaver activity on the lake this spring. They are traveling up/down the Oconomowoc River. Previously they would just be passing through, but several have decided to take up residence, primarily along the eastern side of the lake. You will know if they are in the area because they will

start dropping trees and digging very large burrows.
