The project seeks to extend the footprint of the existing piers to better accommodate the existing 24 boat slips and to enhance the efficiency of its boat docking operations.  - a. CHEMICAL WEED SPRAYING PROGRAM. We have submitted a permit to chemically treat some areas of Okauchee Lake impacted by aquatic invasive species.
 - b. ANIMAL CONTROL REPORT. Mr. Groehler indicated that he has been engaged in animal control since early March. Mr. Groehler anticipates that he may receive additional calls in June when summer residents return. Mr. Groehler brought a beaver blanket (pelt) to demonstrate the size of some beavers in Okauchee Lake. This beaver was estimated to be over 80 lbs.
